**A NON-PROFIT CORPORATION**

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators for the purpose of creating a non-profit corporation under the laws of the State of North Carolina, as contained in Chapter 55A of the General Statutes of North Carolina, entitled "Non-Profit Corporation Act", and the several amendments thereto, do hereby set forth:

1. The name of the corporation is North Carolina Society of Radiologic Technologists

2. The period of duration of the corporation shall be perpetual

(May be perpetual or for a limited period)

3. The purposes for which the corporation is organized are:

- a. To advance the science of radiologic technology.
- b. To assist in establishing and maintaining high standards of education and training in the field of radiologic technology.
- c. To elevate the quality of patient care in the field of radiologic technology.
- d. To engage in any other lawful activity including but not limited to, improving the welfare and socio-economics of radiologic technologists.

4. The corporation is to have the following class or classes of members: (If there are to be no members, so state.)
