The Jane Cox Hendrix – Frances Apple – Post Primary Student Scholarship

Affiliate of the ASRT

This scholarship was originally established to honor the memory of Jane Cox Hendrix, later adding Frances Apple. Both were innovative forces in imaging sciences during their careers. With the Jane Cox Hendrix – Frances Apple scholarship, the NCSRT, Inc. would like to encourage students to apply for and complete their education in an accredited Radiologic Science program.

Scholarship Details

> Eligibility

- Must be currently enrolled in an accredited post primary Imaging Science program. Eligible programs include computed tomography, magnetic resonance imaging, bone densitometry, breast sonography, cardiac interventional radiography, mammography, quality management, sonography, vascular sonography, vascular-interventional radiography, radiologist assistant (RA, RPA), radiation therapy and radiology education or administration
 - Only individuals with a previous certification or degree in the radiologic sciences are eligible.
- 2. Must be a current member of the NCSRT, Inc., and a U.S. Citizen, U.S. national or U.S. permanent resident.
- 3. Must have a minimum GPA of 3.0 (on a 4.0 scale) or a B average, specifically in their post-primary core curriculum.
- 4. Must provide evidence of financial need on application form and in the written applicant interview.

5. Previous awardees are eligible to apply; however, applicants are only eligible to win this scholarship twice.

How to Submit Your Application

- 1. Complete all areas provided in the linked application form. Your application will receive zero points for each blank section. If you answer is zero, write in "0" rather than leave it blank.
- 2. Submit application form and written application interview and ensure your Instructor/Director submits transcript and the evaluation form. Both the application and evaluator forms should be submitted via the form links; each form holds a link in the final question to attach supporting documentation. The applicant's form requires the written application interview to be attached; the evaluator's form requires a copy of the applicant's transcript to be attached. All applications and supporting documentation must be submitted in accordance with the deadline posted on the NCSRT website. Late applications or documentation will not be accepted. The NCSRT will also not solicit supporting documentation missing from the application.
- 3. Only one evaluation and one application per applicant will be reviewed.
- 4. Do not submit additional documents; they will not be reviewed.

Required documents

- Completed application submitted via Google document with attached written applicant interview submitted in the final question on the applicant form. Instructions for the written applicant interview can be found below.
- 2. Completed evaluation form submitted via Google document by your Radiologic Sciences instructor with transcript issued from your institution containing the first semester grades for your entry-level Radiologic Science program. The evaluator will be prompted to attach the transcript in the final question on the evaluator form. Recommendation letters will not be accepted as a substitute for the evaluation form.

Direction for Written Applicant Interview

The applicant interview must be typed on a separate sheet of paper and must not exceed 500 words. Your responses must be double-spaced in 12-point

font. **Do not write an essay.** Number your responses and answer each of the questions listed below. Please save as a document or PDF before submitting.

- 1. What is your reason for entering this Imagin Science profession?
- 2. What are your career goals?
- 3. What is your financial need status?
- 4. Why should you receive the scholarship? Feel free to elaborate on any awards, activities, and special circumstances, etc.

> Application Deadline

Completed applications for The Jane Cox Hendrix – Frances Apple Scholarship must be submitted by the posted date on the NCSRT website. Applicants are responsible for ensuring all required documents, including the evaluator's form and transcript, are submitted in accordance with the posted deadline. The NCSRT will not accept applications beyond the posted deadline or solicit missing information from incomplete applications.

Selection and Notification Process

To safeguard the integrity of the scholarship recipient process, the NCSRT, Inc. has formed a review committee. The committee reviews the blinded application materials and makes final recipient recommendations to the Board of Directors. Applicants are not guaranteed a scholarship, but may reapply the following year, if eligible. Recipients will be notified by email no later than three weeks prior to the NSCRT Annual Conference.

> Distribution of Funds

If you are selected to receive the scholarship, the NCSRT, Inc. will present the scholarship funds to you directly at the NCSRT Annual Conference during the Honors Ceremony. You will be notified of the location and time of ceremony. Funds may be used as long as the recipient is continually enrolled in a Radiologic Sciences program. If the recipient changes programs, disenrolls, or fails to maintain a 3.0 GPA, funds must be returned to the NCSRT, Inc. by the recipient.
