Are you passionate about a scientific topic relating to medical imaging? Did you read an interesting CE article or discover something that blew your mind during your didactic lessons? The NCSRT wants you to tell us about it in an electronic presentation, and you could be recognized at the NCSRT Annual Conference! Read on to learn how to submit your presentation.

APPLICATION DEADLINE: All presentations to be considered must be received by a date set yearly based on committee and board input.

APPLICATION AND PRESENTATION GUIDELINE:

Must be submitted on or before 11:59 pm by the application deadline on the NCSRT website. THERE CAN BE NO EXCEPTIONS. You will receive a return e-mail when your application has been received. Entries submitted for consideration must be from a member of the NCSRT, Inc.

PRESENTATION and WINNERS:

- Competition winners will be awarded their placement on Friday at the Annual Conference Awards Luncheon.
- First, second, and third place winners will be awarded if there is a sufficient number of submissions.
- The NCSRT, Inc. reserves the right to publish or post the submitted works for competition.
- 1st, 2nd, and 3rd place winners will receive plaques in their honor. 1st place winners will also be awarded a \$50 cash prize. Only one winner will be named for each place no ties will be accepted.

ELIGIBILITY:

- Only those technologists or students who hold active, advanced student, or student membership in the Society may submit for consideration.
- The applicant must be a member in good standing at the time of application.
- No committee chairmen or officers of the Society will be eligible to participate.
- Any presenter whose presentation is disqualified will be notified via email after the decision is made by the Committee.

RULES AND REGULATIONS:

JUDGING:

- Three (3) judges shall be selected by the President and will be responsible only to the President.
- The judges' selection shall be based upon the rating listed in the presentation judging evaluation scale.

FORMAT:

- All applications shall be submitted on or before 11:59 pm on the stated deadline.
- Each presentation should be submitted by a single presenter.
- Members should submit a video recording of a presentation on a topic of their choice relating to medical imaging for 10 minutes or less. Videos should be posted to YouTube as unlisted, so that only those with the link to the video may view it. The link to the video will be submitted for consideration for this contest. See this link for information about how to post an unlisted YouTube video.
- The video must not be blurry or lack sufficient volume to clearly understand the speaker in the video.
- A video of slides with voiceover is preferred to enable full discussion of the chosen topic.
 No videos with images of the person submitting the presentation will be accepted to enable blind judging. Submissions can include slides from any source, including Prezi, PowerPoint, etc
- All sources utilized in the presentation must be cited at the end using AMA format.

SUBJECT MATTER

- Presentations must be the work of the individual. The individual's name may be displayed only after judging, and therefore should not be included on the presentation video itself.
- The presentation should consist of a subject pertaining to radiologic sciences or any other imaging modality. It may be supplemented by charts, photos, technical factors, etc., as deemed necessary.
- The exhibit shall not show images or markings that could identify the patient, institution, or department. HIPAA must not be violated any violation of patient privacy included in submissions will face immediate disqualification.
- The layout should consist of an Introduction, Body, and Conclusions.

WITHDRAWALS

• Any exhibitor shall notify the President immediately of a decision to withdraw from exhibit participation.
